


After completion of 20 Years	Re-issuance of OCI card is required once on acquiring a new passport.	Original OCI Card New Passport
50 Years & Above	Reissuance of OCI is NOT required; Only new passport details and new photo has to be updated/uploaded on the OCI Portal once after acquiring a new passport after turning 50.	Original OCI Card New Passport

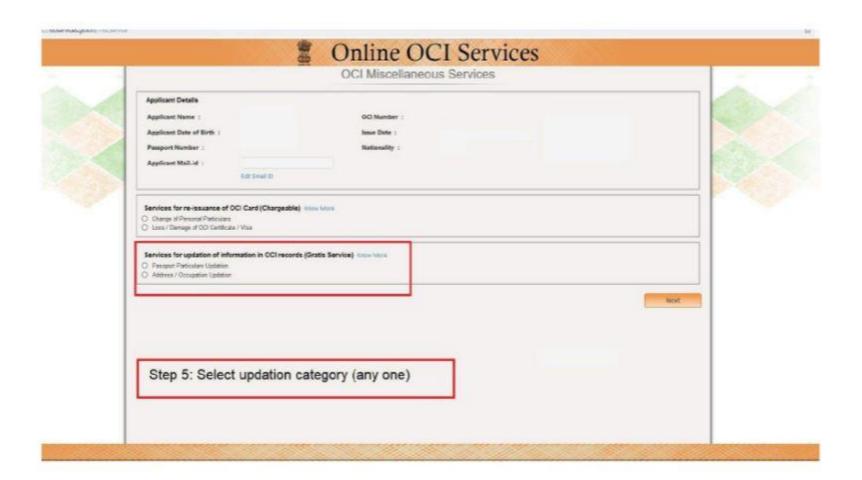
