NMDC Limited, a Navaratna Public Sector Enterprise under Ministry of Steel, Govt. of India is the largest producer of iron ore in India. It owns and operates highly mechanized iron ore mines in Chhattisgarh and Karnataka States, where it produced 35.5 million tonnes of iron ore in FY'18. 


