SCOPE OF WORK

- (i) To supply & install an eight (08) port Ethernet switch in five apartments of the building of the High Commission of India;
- (ii) To provide new networking equipment and appurtenances for a complete installation for internet system in the five apartments;
- (iii) Install CAT 5E cable from main internet switchboard to five apartments;
- (iv) Run additional short cables within the apartments for connection in each room;
- (v) Terminate new fibre-optic cables and extend networking cabling as required for implementation and label all-jacks;
- (vi) Retain the equipment with the existing configuration;
- (vii) The work will be completed in 15 working days from the date of award of work. There will be a penalty of 1% of contract value for per day of delay attributable to the contractor;
- (vii) There will be one year warranty for the quality of material and work. In case of any defect, the contractor will take the corrective action without any cost to this office;
- (viii) No advance payment is permissible. 90% payment will be made within 15 days of presentation of invoice after successful completion of the work and 10% payment will be made after 45 days of the completion of work; and
- (xii) All rubbish is to be removed and discarded by the Contractor after completion of work.
